COUNT 1

The Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, charge and accuse **KATIE MARIE KLOTH, TYLER JOHN NORMAN and HANNAH MARGARET KASS, individually and as parties concerned in the commission of a crime**, with the offense of **CRIMINAL DAMAGE TO PROPERTY IN THE SECOND DEGREE, O.C.G.A. 16-7-23**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 12th day of May, 2022**, did intentionally damage the property of another, to-wit: the office building and fencing located at 2999 Circle 75 Parkway SE, Smyrna, GA, the property of Brasfield and Gorrie LLC, without their consent, by striking and spray painting fencing, windows, and walls by striking them with hands, feet, and thrown objects and painting them with use of spray paint, said damage exceeding \$500.00, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 2

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **KATIE MARIE KLOTH, TYLER JOHN NORMAN and HANNAH MARGARET KASS, individually and as parties concerned in the commission of a crime**, with the offense of **CRIMINAL DAMAGE TO PROPERTY IN THE SECOND DEGREE, O.C.G.A. 16-7-23**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 12th day of May, 2022**, by means of fire, did recklessly damage the property of another, to-wit: the property of Brasfield & Gorrie, LLC located at 2999 Circle 75 Parkway SE, Smyrna, Georgia, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3

and the Grand Jurors, aforesaid, in the name and behalf of the citizens of Georgia, further charge and accuse **KATIE MARIE KLOTH, TYLER JOHN NORMAN and HANNAH MARGARET KASS, individually and as parties concerned in the commission of a crime**, with the offense of **ARSON OF LANDS, O.C.G.A. 16-7-63(a)(1)**, for that the said accused person, in the County of Cobb and State of Georgia, **on or about the 12th day of May, 2022**, with intent to damage, did cause a fire in the brush and straw on the land of another located at 2999 Circle 75 Parkway SE, Smyrna, Georgia, said property owned by Brasfield & Gorrie LLC, without the permission of said owner, contrary to the laws of said State, the good order, peace and dignity thereof.
